MIGHTY VS7® LIMITED LIFETIME PROTECTION WARRANTY

ROYAL PURPLE® FULL SYNTHETIC OIL AND MIGHTY MAX® EXTENDED-LIFE OIL FILTER CHANGES



1) What is the scope of this Warranty?

Mighty Distributing System of America, LLC (Mighty) hereby warrants Mighty VS7® products listed below to be free from material defects in material and workmanship and, if your vehicle is properly maintained, will provide sufficient lubrication, which will prevent mechanical failure due to abnormal wear and corrosion. In the event that the Mighty VS7® products listed, installed professionally, fail to prevent mechanical failure due to abnormal wear and corrosion, Mighty will repair or replace parts of the systems covered, subject to the terms and conditions of this limited warranty.

This warranty is separate from and does not extend the vehicle manufacturer's warranty. It takes effect only after the vehicle manufacturer's warranty ends. Mighty will, however, pay the deductible (vehicle owner's required payment) under an extended service contract, subject to the terms and conditions herein.

To commence coverage, you must have one or more of the following services performed on your vehicle within the mileage intervals outlined herein:

Brake System: service properly, using Mighty VS7® DOT 3 Brake Fluid (BK104, 105, 106) or Mighty VS7® DOT 4 Brake Fluid (BK107, 108).

Cooling System: service properly, using manufacturer equivalent coolant and Mighty VS7® Coolant & Conditioner Kit CL108 (CL103 & CL104).

Differential (Front & Rear): service properly, using manufacturer equivalent fluid and Mighty VS7® Limited Slip Differential Supplement (SB106) **or** Mighty VS7® 75w140 Synthetic Gear Lube (TR110).

Engine (Gasoline): service properly, with Royal Purple® Full Synthetic Oil and Mighty Engine Guard MAX® Synthetic Extended Life Oil Filter change. To initiate the VS7® Lifetime Protection Warranty, must use a Mighty VS7® Oil System Cleaner (OL105 or OL106) during the first service.

Fuel (Gasoline): service properly, using Mighty VS7® service kit (FL116 or SB450 or SB500).

Fuel (Diesel): service properly, using Mighty VS7® service kit (SB400).

Power Steering: service properly, using manufacturer equivalent fluid, Mighty VS7® Power Steering Fluid (PS102 or PS103 or PS112 or PS113) and Mighty VS7® Synthetic P/S 2-Step Service (SB105) or service with Mighty VS7® Synthetic Universal Power Steering Fluid (PS111) and Service Kit (SB120 or PS115).

Transmission: service properly, using manufacturer equivalent fluid or Mighty VS7® (TR120 or TR200) and Mighty VS7® Synthetic 2-Step Transmission Service Kit (SB100). For CVT transmissions use Mighty VS7® Multi-Vehicle CVT Transmission Fluid (SB202).

2) What are the terms of this Warranty? How do I keep it in force?

Subject to the terms and conditions stated herein, these limited lifetime warranties take effect after both **60 days and 750 miles** (the waiting period) after the Mighty VS7® product or products are installed (the effective date). The waiting period is not applicable if the Mighty VS7® product is covered by an existing Mighty Limited Warranty already in effect at the time of service. All maintenance and service obligations begin on the date Mighty VS7® products are installed, regardless of the waiting period.

This warranty for **Engine (Gasoline)** is conditioned upon the performance of the required Mighty VS7® service, as described in section 1 above, with oil and filter change intervals not to exceed the vehicle manufacturer's recommended mileage interval. From the date of the warranty enrollment, the engine must be serviced using only the proper grade and weight of oil as specified by the vehicle manufacturer. In addition, the oil filter must be replaced at each oil change.

This warranty for **Fuel System (Gasoline and Diesel)** is conditioned upon the performance of the required Mighty VS7® fuel system service, as described in section 1 above, within 15,000 miles of the previous service. The timing belt and emission control system must be maintained as specified by the vehicle manufacturer.

This warranty for **Transmissions, Differentials, Power Steering, Brake and Cooling Systems** is conditioned upon the performance of the required Mighty VS7® service, as described in section 1 above, within every 24 months or 30,000 miles of the previous service, whichever occurs first. The warranty is limited to one payable claim per service interval.

All services described above must be performed by a licensed professional service facility. You may not change your own oil or perform other services yourself.

A professional technician must perform approved Mighty VS7® maintenance procedures using proper Mighty VS7® products and equipment. In the event of a claim, you must provide the program administrator with evidence that all the required services were performed within the mileage intervals outlined herein. A grace period of 500 miles will be extended in order to stay in compliance with service interval requirements, including the initial service. Use of any products other than Mighty VS7® branded and/or approved products listed herein will void these limited warranties.

3) What is covered and what is not covered by this Warranty?

Payment of claims is limited to the labor hours necessary to make repairs or to replace any irreparably damaged parts as specified by **Motor or Mitchell Flat Rate Guide** or other recognized industry guide, multiplied by the repair shop's normal hourly rate, and the reasonable cost of the parts replaced of the kind and quality determined by the warranty administrator. Qualified repair expenses do not include rental vehicle expenses, towing, shop supplies and other similar expenses.

3) What is covered and what is not covered by this Warranty? (continued from front page)

This warranty covers only the lubricated parts within the following systems:

Brake System: The pumps, master cylinder, calipers, valves and metalized hoses are covered. Brake pads and shoes, rotors, ABS sensors, controller and other electrical parts are not covered.

Cooling System: The heater core, water pump, radiator and freeze plugs are covered. Hoses, clamps, engine components and thermostats are not covered.

Differential (Front & Rear): Only lubricated parts *contained within* the front and rear housing or case are covered. The housing or case, the axle bearing(s), U-joints, CV joint(s) and boot(s) are not covered unless damaged due to a covered part.

Engine (Gasoline): The following items are covered: Pistons and rings, oil pump, cam shafts & bearings, turbo bearings, valve lifters, push rods, crankshaft & bearings, timing gears/sprockets, timing chains, rods/rod bearings, intake valves & guides, cylinder guides/bores, rocker arms & pivots, and distributor drive gears. Timing belts and damage due to broken timing belts are excluded. Grinding adjustments to intake valves and guides are also excluded.

Fuel System (Gasoline or Diesel): Oxygen sensors, PCV and deposit related malfunctions related to injectors are covered.

Power Steering: The power steering gear box (or rack) and pump are covered. The hoses, belts, brackets and leaking seals and gaskets are not covered.

Transmission: The transmission housing or case is covered only when it is damaged by an internally lubricated part covered by this warranty. Fluids used must always meet the specifications of the vehicle manufacturer. Leaking seals and gaskets, and electrical components are not covered.

4) What conditions must be met? What are the exclusions?

This warranty covers only legally registered privately owned passenger cars, SUVs, vans and pick-up trucks up to 9,500 pounds of gross vehicle weight that are used exclusively for personal use. Motorcycles, RVs and vehicles with more than two axles are not covered. Vehicles used for competitive or commercial purposes are not covered. Leased vehicles are covered when leased by an individual who is primarily responsible for maintenance and repair. Vehicles used for towing a trailer or other objects are not covered unless the vehicle is equipped with a factory installed towing package. Any claim resulting from collision, fire, theft, vandalism, contamination of fluids or failure to perform normal maintenance specified by the vehicle manufacturer will void this warranty. Pre-existing conditions, damage to system components occurring prior to service are excluded. Any vehicles classified as salvaged or junk titled vehicles are also excluded. *Important: To keep this warranty in effect, you must keep all receipts and repair orders for maintenance and services required by this warranty. Failure to provide all records will render this warranty null and void.*

5) How much will I be reimbursed? Are there any limits?

The Mighty VS7[®] Limited Lifetime Protection Warranty reimbursements will not exceed the amounts shown in the table below (including taxes) for each vehicle system or the actual cash value of the covered vehicle after the completion of repairs, whichever is less. The actual cash value to be determined using Kelley Blue Book.

6) What are the claims procedures that must be followed?

In the event of a claim, you must contact the Claims Administrator at 1-800-829-3900 Monday through Friday, between 7:30 am and 5:30 pm eastern time, **before** any repairs are made. **Repairs not authorized by Mighty will not be paid.**

You must provide Mighty with a complete statement of damages and repair costs and if requested, the damaged parts, a sample of the fluid involved with the damaged part(s), and copies of all repair orders showing installation of the Mighty VS7[®] products involved with the damaged parts and demonstrating compliance with the terms and conditions outlined herein. After the claim has been approved in writing, repairs must be made by the original Mighty VS7[®] authorized retailer or any other authorized Mighty VS7[®] retailer. Mighty reserves the right to verify the validity of claims through an independent analysis.

7) Is this Warranty transferable?

Yes. These warranties are transferable to a subsequent owner of the vehicle covered.

Mighty is not responsible for incidental or consequential damages. These warranties will only apply to authorized repairs made for vehicles operated in the United States of America. This warranty gives you specific legal rights, and you may have other rights, which vary from State to State.
